Rules for granting scholarships of the CTU in Prague

1 Introductory provisions

This dean's instruction specifies the conditions for scholarship applicants for excellent academic results in accordance with the Scholarship Regulations of the Czech Technical University in Prague and sets, after approval by the AS FTS, the decisive section for the payment of the scholarship and other binding deadlines.

In the following academic year 2024 - 2025, scholarship will be awarded and paid for excellent study results (hereinafter "merit scholarship") achieved in the academic year 2023 - 2024 to students of the bachelor's degree and master's degree study programs at CTU in Prague Faculty of Transportation Sciences meeting the prescribed criteria according to the Scholarship Regulations of the Czech Technical University in Prague (hereinafter referred to as the CTU SR).

Students do not apply for the scholarship; the merit scholarship will be awarded to all students who meet the conditions for the award of a merit scholarship according to the records in the KOS system. It is therefore necessary to have all completed courses in the academic year 2023 - 2024 recorded in the KOS system, no later than 07.10.2024. If the completion of the course you have completed is not recorded in the KOS system, please contact the relevant teacher with a request to insert this record.

Students who have met the criteria for the award of the merit scholarship and are not included in the list, which will be published no later than 14.10.2024 on the faculty's website (<https://www.fd.cvut.cz/o-fakulte/vnitri-predpisy.html#prospechove>) shall submit an electronically completed and hand-signed (Generic) request for a scholarship, published at <https://www.fd.cvut.cz/english/students/students-forms.html>, no later than 21.10.2024 to the Study department.

2 Deadline and amount of the merit scholarship

In accordance with Article 3, par. 8 of the CTU SR, I set the deadline for the payment of merit scholarships:

- the scholarship is provided for a maximum of 10 months of the academic year 2024–2025 in accordance with Article 3, par. 5 of CTU SR
- I set the deadline for the payment of merit scholarship at November 2024
- the merit scholarship is paid to the bank account number specified by the student in the KOS system

In accordance with Article 3, par. 11 CTU SR I set:

- the decisive section of the study for the payment of the merit scholarship is the whole academic year 2023–2024 (2 semesters)
- I determine the amount of the merit scholarship after the statement of the Academic Senate of the Faculty of Transportation Sciences as follows:
